## Details about the 2021 TMUNxUSR Compassionate Community Photography Competition

#### 1. Purpose

The purpose of the 2021 TMUNxUSR Compassionate Community Photography Competition is to promote the concept of a compassionate community and demonstrate the culture of helpfulness among the community and its members through texts and images.

#### 2. Advisor

Ministry of Education of the Republic of China (Taiwan)

#### 3. Organiser

University Social Responsibility (USR) Project, College of Nursing, Taipei Medical University

#### 4. Entry Information

Photos should be taken with the community as the theme and demonstrate the concepts of compassionate community care, including hospice friendly, dementia friendly, age friendly, and etc.

#### 5. Eligibility

- (1) Participants are divided into different groups:
  - A. College and University Students Group: This group is for students enrolled in colleges and universities acknowledged by the Ministry of Education. Participants under the age of 20 must have the parental consent form signed by their parents (Appendix II).
  - B. Older Adults Group: This group is for people aged over 55 years who are interested in photography.
- (2) Participation is limited to individuals. An entrant can submit multiple entries (Each person can only win one award. People winning multiple awards will only be granted the highest award).

#### 6. Terms and Conditions

- (1) All 'Photographs' submitted for the competition must be saved as digital files.
- (2) Please keep the original files of all entries.
- (3) 'Short Essays' must be written in Chinese or English. For Chinese essays, the word count is limited to 300 words, including punctuation marks. For English essays, the word count is limited to 350 words, including punctuation marks.
- (4) The uploaded 'Photograph' must have a size less than 10MB and be in JPG format. The photo dimension should be at least 2,400 pixels by 3,600 pixels. Both vertical and horizontal images are allowed.
- (5) All entries must be created independently by the participant.
- (6) Photographs entered in the competition must be taken by the entrant. The use of photographs taken from the Internet and galleries is strictly prohibited. Do not violate the terms and conditions of the competition and the copyright law. Entries found in violation of these rules will be disqualified.
- (7) Post-processing of images is allowed.
- (8) By registering for the competition, participants agree to the terms and conditions and agree that they have not violated any agreement with third parties. In addition, they guarantee that their entry is original and does not infringe the copyright, trademark, personality, privacy/publicity, or intellectual property rights of any other person or entity. It is also assumed that no third party has any rights, titles, claims, or interests in the entry, and there is no violation of other laws and regulations.

- (9) The organiser reserves the right to inspect all entries and/or source materials to confirm their compliance with the terms and conditions.
- (10) Entries must not promote any illegal activities and behaviours.

#### 7. Registration

Submission requirements:

- (1) Photograph: Photographs must have a size less than 10MB and be in JPG format. The photo dimension should be at least 2,400 pixels by 3,600 pixels. Both vertical and horizontal images are allowed.
- (2) Short essay: Short essays must be written in Chinese or English. For Chinese short essays, the word count is limited to 300 words, including punctuation marks. For English short essays, the word count is limited to 350 words, including punctuation marks.
- (3) The front and back of the participant's student ID or proof of enrolment (for the College and University Students Group).
- (4) Competition Registration Form (Appendix I).
- (5) Parental Consent Form for Minor Applicants (Appendix II).
- (6) Liability Waiver Form (Appendix III).

- Older Adults Group:
- Winner: A gift voucher worth NT\$ 2,000 and a certificate of commendation
- Runner-up: A gift voucher worth NT\$ 500 and a certificate of commendation
- All participants: An electronic participation certificate

- \* The prizes awarded in this competition cannot be exchanged for monetary value or any other item or transferred to other people. Prizes can be replaced with items of equivalent value for reasons that cannot be attributed to the organiser. Actual prizes are subject to the announcements made by the organiser. Winners agree that the organiser is not responsible for any events after prizes are accepted.
- \* Prizes are determined by the judging committee based on the level of the entry. When necessary, the number of winners can be adjusted or there can be no winners.
- \*\* All prizes are subject to the tax law of the Republic of China (Taiwan). For domestic winners, a 10% withholding tax will be deducted for prizes with a single payment of NT\$ 20,000 (inclusive) or more. For foreign winners, a 20% withholding tax will be deducted regardless of the prize amount.

#### 11. Other Terms and Conditions

- (1) The Organiser of this event is the Taipei Medical University, hereinafter referred to as 'the Organiser'.
- (2) The Organiser has the right to use all entries for promotional activities during this competition.
- (3) Participants who fail to comply with the competition's terms and conditions are deemed to have forfeited the competition. In this case, the Organiser has the right to disqualify his/her entry directly.
- (4) Entries will not be returned. Participants are advised to save a copy of the file.
- (5) Participants should read and agree to all terms and conditions listed in this document. The Organiser reserves the right to change or modify any of the terms and conditions at any time.
- (6) If the entry uses any published text, video records, or third-party works (such as props and trademarks), a signed consent from the third party must be obtained that gives the participant permission to use the material. In addition, the consent should allow the Organiser and the participant to reproduce, edit, modify, distribute, and publish the material for non-profit promotional activities during the competition.
- (7) The participant must be the original creator of the entry.
- (8) Entries should not have been published anywhere else. Plagiarism, borrowing, copying, or counterfeiting is strictly prohibited.
- (9) Entries should not be published publicly without the Organiser's approval. There must be a signed copyright permission letter (the work shall not illegally infringe the copyright or other rights of others).
- (10) The entrant shall be responsible for any dispute over the intellectual property rights of their entries. The Organiser will not be held responsible.
- (11) If the winning entry violates laws and regulations related to intellectual property rights, the award certificate and prize money shall be returned to the Organiser, and the winning entry will be disqualified.
- (12) The winner of an award may not request to be disqualified from the award.
- Oisclaimer: By choosing to participate in this contest, the participant agrees to release, waive, and exempt the Organiser—Taipei Medical University—and its partners, affiliates, subsidiaries, advertising agencies, agents, employees, directors, and representatives from any claims, losses, and damages arising from their participation in this contest and contest-related activities, as well as from the acceptance, use, misuse, or possession of the prizes received from the contest. # 2021 TMUNxUSR Compassionate Community Photography Competition

**Liability Waiver Form** 

- 1. To ensure the fairness of the event, the participant, hereinafter referred to as 'the entrant', hereby signs this liability waiver form to participate in the '2021 TMUNxUSR Compassionate Community Photography Competition' to appeal to public trust.
- 2. The entrant guarantees that the visual works and essays submitted are the original work of the entrant and that he/she owns or has the right to use the intellectual property rights of the 'visual works' he/she has created. The entry must be created by the entrant himself/herself and shall not be a copy or excerpt of any other published or unpublished concepts, ideas, and works. The entrant shall be fully responsible for the intellectual property rights and related laws of his/her creative project. If a part or all of the content of the creative project is found to have been copied from others, the Organiser can immediately disqualify the entrant from the competition.
- 3. The entrant, when applying for the competition, should take the initiative to inform the Organiser if the content of their creative project has already won awards in other competitions. If the entrant does not inform the Organiser, the Organiser may immediately disqualify the entrant from the award and require the entrant to immediately return the prize money they received unconditionally without any objection.
- 4. The source and origin of all quoted information should be properly cited to avoid violating copyright and other related laws. If there is an infringement of the intellectual property rights of others or other laws and regulations, resulting in litigation disputes, all costs and losses incurred will be the responsibility of the entrant. The Organiser shall not be responsible for the related liabilities.
- 5. The entrant agrees to provide the Organiser with information regarding their participation in the competition, such as their proposal and personal information. The Organiser will be allowed to use the content of the entrant's creative project in the 2021 TMUNxUSR Compassionate Community Photography Competition. The Organiser will be allowed to preserve and reproduce the content in various forms, such as digitisation, online dissemination, exhibition, and editorial publications. The Organiser has the right to photograph, record, and exhibit the content after submission. Regardless of the form, the Organiser shall be authorised to reproduce it free of charge, and the entrant shall not request compensation.
- 6. By signing this liability waiver form, the entrant agrees to grant the Organiser a usage license without compensation.
- 7. Only the winners can collect prizes. Winners must provide proof of identity and other documents and pay the relevant income tax in accordance with the tax laws of the Republic of China (Taiwan).
- 8. Entries are non-returnable. The entrant should make their own copies.
- 9. Participants must abide by all the rules and regulations of the competition and decisions made by the judges. Participants will not object if they are eliminated due to their failure to comply with operating hours and regulations.
- 10. For other unspecified matters, the Organiser reserves the right to amend, suspend, and terminate the event at any time. Participants are not allowed to object.
